### Tolls for Transportation Service on the South Suffield Pipeline

(As approved in RH-002-2020)

Effective November 1, 2021 - (Revised September 29, 2021)

South Suffield Pipeline Location	Beginning at the C Meter Station located at 1-4-15-8W4 and terminating at the Burstall Meter Station located at 7-8-20-29W3.	
Production Receipt Point	Tie in point to South Suffield Pipeline	
<b>Firm Transportation Service</b>		
Firm Contract Demand	Shipper’s subscribed annual volume calculated in GJ per day, shipped rateably.	
Load Factor	Customer must use or otherwise pay for 100% of Firm Contract Demand	
Term	One (1), two (2), five (5), ten (10), and /or twenty (20) years

Toll for Interruptible Preferred Transportation Service	<p>For two, five, ten and twenty years \$0.02/GJ plus the applicable Toll for Firm Transportation Service.</p> <p>For one year \$0.03/GJ plus the applicable Toll for Firm Transportation Service.</p>	
<b>Interruptible Transportation Service</b>		
Interruptible Volumes	Any volume of gas delivered by the Shipper onto the Pipeline (i) pursuant to a Transportation Service Agreement for Interruptible Transportation Service, or (ii) in excess of the Shipper's Firm Contract Demand and Preferred Interruptible Volume Entitlement	
Market-Responsive Toll for Interruptible Transportation Service	<p>The toll for Interruptible Volumes is the market-responsive toll for Interruptible Transportation Service posted Transporter's website and in effect on the day that the Transporter provides Interruptible Transportation Service to the Shipper.</p> <p>Transporter may from time to time, in its discretion, adjust the Market-Responsive Toll for Interruptible Transportation Service to an amount that may be equal to or less than the Maximum Toll for Interruptible Transportation Service.</p>	
Maximum Toll for Interruptible Transportation Service	\$0.32/GJ	

<p>Communication Methodology</p>	<p>Transporter shall communicate its Market-Responsive Toll for Interruptible Transportation Service to shippers, and any adjustments thereto, by:</p> <ul style="list-style-type: none"> <li>(a) posting the toll, as adjusted from time to time, on Campus's website at (or at a web link accessible through):  <a href="https://www.campusenergy.ca/Infrastructure">https://www.campusenergy.ca/Infrastructure</a>;  and</li> <li>(b) providing email notification to all shippers with a Transportation Service Agreement for Interruptible Transportation Service of any adjustments to the Market-Responsive Toll for Interruptible Transportation Service on the same day that adjusted toll is posted on the Transporter's website.</li> </ul>
<p>Effective Date for Adjustments to the Market-Responsive Toll</p>	<p>Any adjustment to the Market-Responsive Toll for Interruptible Transportation Service takes effect the day after the new toll is posted on the Transporter's website and shall continue in force until the day after a newly adjusted toll is next posted on the Transporter's website.</p>
<p><b>Notice of Toll Changes</b></p>	
<p>Notice Period</p>	<p>Transporter will provide Shippers with at least three (3) months written notice of any change to:</p> <ul style="list-style-type: none"> <li>(a) any of Tolls for Firm Transportation Service; or</li> <li>(b) the Maximum Interruptible Toll.</li> </ul>
